## A and Z Stamps

Please note that the A & Z cannot be used after a dogs name unless it has been x-rayed through National Council Schemes. If you have an animal x-rayed through the BVA you CANNOT use the A & Z stamp when entering shows or trials.

## Breed Survey Scheme

At the 2013 GSDCA Annual General Meeting held in Melbourne it was resolved that the charges for the GSDCA Breed Survey Scheme would increase as from the **1st of July 2013**.

The determined fees from 1<sup>st</sup> July 2013 are :-

Charges to the owners via member clubs	<b>\$35.00 (Inc GST)</b>
GSDCA charge to member clubs	<b>\$27.00 (Inc GST)</b>

**Also please note – all paperwork for Breed Survey is to be forwarded to the NSW Registrar, Pam Jarvis, one week prior to the Survey and a cheque/money order is to accompany the paperwork. It is also necessary for you to bring the original paperwork also to survey which is to be sighted by the surveyor surveying your dog.**

## Australian Bred Class

Please note that whilst the GSDL will maintain the Australian Bred Class at its future shows we are unable to issue the grading of Excellent in this class due to an objection lodged by National Council who have stated that they will advise judges that this grading is not to be given in the Australian Bred Class. The GSDL feel that judges should not have this kind of pressure placed upon them when judging.

The GSDL will be lodging a motion to the next Council AGM to have the grading of Excellent also awarded to the Australian Bred Class.

Those animals who received the Excellent grading at our last show will not have this removed nor the points they received.

## **PRESIDENTS REPORT**

The nationals for 2014 is well and truly past but congratulations go to those GSDL exhibitors that had success with their dogs. Also congratulations to Andacht Kennels who won the Breeders group and the Sam Bonifacio Trophy for the highest scoring kennel at the show.

Our State Breed Assessment in July was well-represented and further congratulations to those owners who had a successful show with their exhibits.

Of course there are numerous exhibits that had a rewarding show in both shows and too many to name individually.

It was disappointing that the DOGS NSW Spring Fair Committee, in their wisdom, declined to have the GSDL participate in the Spring Fair this coming September with two GSD Specialist Shows run by the GSDL. The difficulty was that the Spring Fair is held on the same weekend, or in very close proximity, to the German Sieger Show. Hence it was impossible to contract German Judges for that show. Also, many exhibitors that would, under normal circumstances, enter the Spring Fair, attend the Seiger Show to observe. This affected the numbers at the show and hence the decision to eliminate the GSD Speciality Shows from the Spring Fair. A very disappointing decision but made from a monetary perspective by the Spring Fair Committee. Positively, Dogs NSW has allowed us to extend our October show to over two days, rather than one day of exhibition. This will happen in 2015.

Going back further, our Easter Show, Judged by Juergen Maibuchan SV (GMY). This show was very well represented and it is hoped that the show on the Easter weekend will be the highlight of the year in the future with having German Judges assessing the exhibits. Congratulations are also extended to those successful exhibitors.

The GSDL has many long-standing members. Congratulations go to Alan and Judy Connors who were awarded life membership for their long-standing and tireless input into the GSDL.

It is sad to make note that a long-standing member and breeder, Yvonne Cooper, passed away after a long illness. A few members that knew her well, especially with her breeding, assisted her to tidy up her affairs, as she had no family in Australia.

On 26th July the GSDL entered a team in the Interclub Challenge. We are proud to announce they won the trophy for Highest Achieving Breed Specialty club and placed 3rd overall out of 31 teams. Photos and a report will be in the next Shepherd News.

## **Policy concerning the use of Information Technology and Social Media (“Policy”)**

Adopted November 2013

### **About the Policy**

Dogs NSW has an obligation to its members to provide a safe environment both physically and emotionally. This obligation is not limited to the confines of the show ring or trial field or Dogs NSW events], but includes ensuring that Information Technology (IT) is not used by our members in a destructive or counterproductive way. Dogs NSW acknowledges that IT provides beneficial and important platforms for both business and personal communication which allows the sharing of information in online communities.

However, Dogs NSW has recognised the potential for IT to be used inappropriately and/or in a manner which may be considered to be bullying or even illegal. The Policy has been prepared to promote a healthy environment within which Dogs NSW members can use IT in a constructive manner.

### **To whom does the Policy apply?**

This policy concerns the use of IT by all members of Dogs NSW and applies to any IT services accessed by these parties through Dogs NSW IT systems or through personal IT devices by those to whom the Policy applies, whether at Dogs NSW events or outside of these times.

### **To what does the Policy apply?**

The Policy applies to the use of Information Technology, including but not limited to:

1. Social Media;
2. Email services;
3. Instant messaging services;
4. Text messages; and
5. Telephone calls.

### **What is Social Media?**

“Social Media” includes online services and tools used for publishing, sharing and discussing information. Social Media includes, but is not limited to, social networking sites, microblogging sites, weblogs, video and photo sharing sites, online forums or discussion boards, online encyclopaedias, wiki pages and any other websites which allow users to upload and share content on the internet.

### **Your obligations**

In line with the Policy, you must:

1. abide by the Articles of Association of Dogs NSW (Royal NSW Canine Council Ltd).
2. act in a manner which would fall within community expectations of good manners;

3. be courteous and respectful to Dogs NSW, Dogs NSW's staff members, members, all affiliates of Dogs NSW and others;
4. not disparage Dogs NSW, its staff members, members or affiliates, either expressly or implicitly;
5. not engage in Cyber Bullying;
6. not utilise abusive, profane, obscene or sexually explicit language or material;
7. obtain written permission from Dogs NSW before posting any content on a Social Media platform or using any IT service to make statements or comments on behalf of Dogs NSW or otherwise or which may be construed to be attributed to Dogs NSW.

The Articles of Association of Dogs NSW include prohibitions on the engaging of various forms of conduct by Dogs NSW Members including prohibitions on members engaging in any conduct that could reasonably be considered to be:

- (a) dishonest, malicious, vexatious or scandalous or contrary to law;
- (b) discreditable to the member concerned or any other member;
- (c) prejudicial or injurious, or tending to prejudice or injury any person interested in canine affairs;
- (d) prejudicial or injurious, or tending to prejudice or injure the interests, image or standing of Dogs NSW;
- (e) contrary to the spirit and intent of the articles, regulations, or any code, resolution, policy or direction of Dogs NSW or any committee.

The Articles also contain a prohibition on members conducting themselves in such a way as to bring Dogs NSW into discredit or to bring themselves as a breeder, owner, exhibitor or member into discredit.

Disparaging behaviour includes but is not limited to the use of IT or the posting of any material on any Social Media platform which causes harm to a person, causes a person (whether a staff member, member or affiliate of Dogs NSW or otherwise) to feel teased, discriminated against, insulted, harassed, offended, embarrassed or humiliated, or causes a person to apprehend that this feeling has been caused to another. Examples can include but are not limited to the posting of derogatory or sarcastic remarks about Dogs NSW, its staff members, members and affiliates on Social Media or by the use of IT generally.

Cyber Bullying means the use of IT or Social Media to act out repeated, unreasonable and unwelcome behaviour which is directed towards an individual or a group, whether Dogs NSW, its staff members, members and affiliates or otherwise, and which creates a risk to the health and safety or otherwise offends, humiliates, threatens or intimates that individual or group.

Disparaging behaviour and Cyber Bullying by Dogs NSW members will not be tolerated by Dogs NSW and may result in disciplinary proceedings.

### **Use of the Dogs NSW Logo**

The Dogs NSW logo must not be used without prior written authorisation from Dogs NSW CEO.

The Dogs NSW logo must not be altered by any person to whom the Policy applies. It must not be used by any person using an IT service, whether Social Media or otherwise, in a manner which may convey Dogs NSW in a negative light or which may cause offence.

## **No association with Dogs NSW when making personal statements**

Dogs NSW members must not attribute personal statements, opinions or beliefs to Dogs NSW when using IT or Social Media, whether expressly or implicitly. If you are expressing your beliefs and/or opinions in posts, you must not, expressly or implicitly, represent yourself as a representative of Dogs NSW. You must assume any and all risk associated with IT and Social Media personally.

## **Obligations of Dogs NSW**

Dogs NSW undertakes to:

1. develop and maintain rigorous practises to ensure compliance with the Policy;
2. ensure that effect is given to the Policy, including but not limited to circulation of the Policy to those to whom it applies;
3. ensure that the benefits of IT and/or Social Media are maximised whilst minimising risk to those to whom this Policy applies, and others; and
4. take actions as determined appropriate by Dogs NSW, on a case-by-case basis, to manage risks arising from the use of IT and/or Social Media.

## **Breach of the Policy**

Dogs NSW takes its responsibility in developing and monitoring compliance with the Policy seriously. All reports of misuse of IT and/or Social Media by Dogs NSW members will be investigated.

If you breach the Policy, disciplinary action may be taken. Disciplinary action may include:

1. referral of the matter to a Disciplinary Tribunal [to be convened by Dogs NSW]; and/or
2. information being provided to NSW Police.

Other disciplinary action that may be taken includes, but is not limited to, issuing a formal warning, education and training as to acceptable uses of IT and/or Social Media and suspension from Dogs NSW.

## **What to do if you observe breaches of the Policy**

Any complaints about breaches of the Policy will be dealt with seriously, confidentially and expediently. In the first instance, advice and assistance can be provided by the Directors, Dogs NSW CEO and the Animal Welfare & Community Liaison Officer.

*Please Note: this policy is being enforced by Canine Control bodies and some have already taken action with members over breaches. Please read it carefully and keep it in mind when using public forums.*

To all GSDCA Member Clubs,

Dear Secretary,

At the 2014 GSDCA Annual General Meeting held in Adelaide on the 8th and 9th of February, the following motions were placed on the GSDCA Agenda by the German Shepherd Dog Club of South Australia and subsequently carried:

1. *That as from 1st July 2014 the GSDCA introduces the Near Normal grading for the GSDCA Elbow Dysplasia Control Scheme for those animals displaying slight irregularities or immeasurable changes. (These animals previously were awarded a Grade One grading showing 0mm of change)*
2. *That as from 1<sup>st</sup> July 2014 an animal must receive an overall grading of Normal, Near Normal or Grade One to be awarded a GSDCA 'Z' stamp through the GSDCA Elbow Dysplasia Control Scheme.*

These motions come into effect on the 1<sup>st</sup> of July 2014 which means that any animal assessed with a Grade Two grading on any elbow *will be deemed to have failed* the GSDCA Elbow Dysplasia Control Scheme and therefore will not be able to be presented to the GSDCA National Breed Survey Scheme.

<b>Normal</b>	No changes	'Z' Normal(0/0)
<b>Near Normal</b>	Slight irregularities	'Z' Near Normal
<b>Grade One</b>	Osteophytes less than 2mm	'Z' Grade One
Grade Two	Osteophytes of more than 2mm to 5mm	Not recommended for breeding – Recorded as a Fail
Grade Three/UAP	Severe changes greater than 5mm	Not recommended for breeding – Recorded as a Fail

*(Gradings in bold are deemed a pass and gradings in normal font are not recommended for breeding)*


"Where's that squirrel? I sent him off an hour ago to bring me another panther!"
