## **MEMBER CLUBS**

Dear Secretary,

I refer to the letter dated 11<sup>th</sup> June 2009, which was sent to the ANKC Administrator and Canine Control Chief Executive Officers and was also copied to all Member Clubs, regarding the following motion :

Re : Request from the German Shepherd Dog Council of Australia that the ANKC recognise permissible colours for the registration of German Shepherd Dogs on the ANKC Main Registrar be those that were submitted to the ANKC on the <u>18<sup>th</sup> November 2005.</u>

The situation that has developed over the past twelve months in regards to the permissible colours for German Shepherd Dogs is unbelievable, and has meant confusion not only for breeders, Canine Control employees but more importantly for the general public when they purchase a '*black and yellow*' German Shepherd Dog.

The word 'gold' and the word 'tan' and 'sable' have been used when describing a German Shepherd Dog since the adoption of the SV standard. Translation of the standard should be translated into dog terminology relative to the breed and this is certainly not the case with the English version of the FCI standard on the FCI website.

The GSDCA has always believed in the adoption of the standard of the "country of origin" and fought very long and hard for the ANKC to adopt the SV standard.

We have approached the National Breed Standards Committee on a number of occasions recently to request that some **common sense** be applied regarding the alteration of the word 'yellow' to 'gold' but to date we have not received any replies to our breeders concerns. The German Shepherd Dog Council is receiving increasing pressure from the members to be proactive on this issue.

We do not want to change the standard we just want a correct translation which clearly and correctly describes the German Shepherd Dog, similar to the standard which has been used in Australia for a number of years.

We have a number of members in our fraternity that are acknowledged as being professional interpreters from German to English and I can assure you that they all agree that the use of the word 'yellow' as a colour for the German Shepherd Dog is incorrect.

In addition to the colour description issue, the use of the word 'rump' instead of croup in the English version of the German Shepherd Dog standard on the FCI website is another clear misinterpretation.

It should be noted that whilst earlier in 2009, some verbal discussions were held with the National Breed Standards Committee, it is disappointing that despite a number of emails over the past couple of months, the German Shepherd Dog Council has received no further response from the National Breed Standards Committee on this matter.

The National Breed Standards Committee, via the Chairperson, Mr. Roger Bridgford, approached the German Shepherd Dog Council of Australia in 2005 and requested confirmation of the applicable 'colours' as permitted on the Main Register, Limited Register and for inclusion to also be made of those colours that are a disqualification as per the Breed Standard, hence not permitted for registration.

This information was prepared by Dr Karen Hedberg (GSDCA Judges Chair) and subsequently forwarded by the GSDCA Secretary on the 18<sup>th</sup> November, 2005 to Mr. Bridgford and copied to Tracy Barry as ANKC Administrator. Clearly outlined were the permissible colours for ANKC registration for German Shepherd Dogs.

In fact Dr Karen Hedberg made the comment at that time that the colour issue in regards to the German Shepherd Dog is relatively straight forward. Unfortunately the submission has not been adhered to. This situation and decision on the part of the National Breed Standards Committee is not acceptable to our members.

It is now a matter of urgency that the ANKC recognise the colours as detailed in the original submission:-

#### Colours PERMITTED on the Main Register.

The colours that are permitted on the Main Register for German Shepherd Dogs are:

- Black;
- Black and Red / Gold / Tan / Brown and Grey;
- Greys are also called sable and can be red or grey sable.

We request that in light of the motion that has been put forward by the Tasmanian Canine Association and Dogs Victoria, circulated on the 10<sup>th</sup> of June 2009, that the request of the German Shepherd Dog Council of Australia receives a positive response which will end this fiasco, not only for the benefit of our breeders but more importantly, for the general public and for the Breed.

The simple solution which would resolve all of our concerns, including the 'rump' (croup) issue, would be for the ANKC to revert to the translated SV German Shepherd Dog Breed Standard as accepted by the ANKC since 1993.

Following this Dogs West prepared another motion which was moved by Dogs West (*Item 1 attached*) and seconded by Dogs NSW (*Item 2 attached*).

I am pleased to advise that the Canine Controls dealt with this matter as a "circular resolution" which was approved by the majority of Canine Controls, *(detailed below)*.
