Heat Stroke in Dogs

Heat stroke is an emergency and requires immediate treatment. Because dogs do not sweat (except to a minor degree through their foot pads), they do not tolerate high environmental temperatures as well as humans do. Dogs depend upon panting to exchange warm air for cool air. But when air temperature is close to body temperature, cooling by panting is not an efficient process.

Common situations that can set the stage for heat stroke in dogs include:

- Being left in a car in hot weather
- Exercising strenuously in hot, humid weather
- Being a brachycephalic breed, especially a Bulldog, Pug, or Pekingese
- Suffering from a heart or lung disease that interferes with efficient breathing
- Being muzzled while put under a hair dryer
- Suffering from a high fever or seizures
- Being confined on concrete or asphalt surfaces
- Being confined without shade and fresh water in hot weather
- Having a history of heat stroke

Heat stroke begins with heavy panting and difficulty breathing. The tongue and mucous membranes appear bright red. The saliva is thick and tenacious, and the dog often vomits. The rectal temperature rises to 104° to 110° F (40° to 43.3° C). The dog becomes progressively unsteady and passes bloody diarrhoea. As shock sets in, the lips and mucous membranes turn gray. Collapse, seizures, coma, and death rapidly ensue.

Treatment: Emergency measures to cool the dog must begin at once. Move the dog out of the source of heat, preferably into an air-conditioned building. Take his rectal temperature every 10 minutes. Mild cases may be resolved by moving the dog into a cool environment.

If the rectal temperature is above 104°F, begin rapid cooling by spraying the dog with a garden hose or immersing him in a tub of cool water (not ice water) for up to two minutes. Alternatively, place the wet dog in front of an electric fan. Cool packs applied to the groin area may be helpful, as well as wiping his paws off with cool water. Monitor his rectal temperature and continue the cooling process until the rectal temperature falls below 103°F (39°C). At this point, stop the cooling process and dry the dog. Further cooling may induce hypothermia and shock.

Following an episode of heat stroke, take your dog to a veterinarian as soon as possible. Heat stroke can be associated with laryngeal edema. This seriously worsens the breathing problem and may require an emergency tracheostomy. An injection of cortisone before the onset of respiratory distress may prevent this problem.

Other consequences of hyperthermia include kidney failure, spontaneous bleeding, irregular heartbeat, and seizures. These complications can occur hours or days later. We are proud to announce the opening of a new branch in 2013

Future Post Entry Quarantine Arrangements - Update on Progress

I am writing to provide an update on progress with the design work for the future Commonwealth post entry quarantine (PEQ) facility being developed in Melbourne.

As previously advised, in the 2012-13 Budget the Gillard Government allocated \$379.9 million over seven years for the construction and operation of a new post entry quarantine (PEQ) facility for high risk plant and animal imports.

The project will replace the five current Commonwealth operated PEQ facilities with a sustainable, reliable facility that adopts modern technology and operating practices. It will deliver a state-of-theart facility that will consolidate existing animal and plant services in a single, integrated site in Victoria.

This builds on the government's announcement in the 2011-12 Budget, where funding was provided to commence design work and acquire a suitable site, along with funding the refurbishment of existing Commonwealth operated PEQ facilities.

The acquisition by the Commonwealth of a site of 144 hectares in Mickleham, Victoria for the development of the facility was announced by the Member for McEwen, Rob Mitchell MP, on 5 July 2012.

Detailed design work will continue over the next 12 months to confirm the size, structure and layout of the new facilities before construction commences.

The proposal will shortly be referred for consideration under the Environment Protection and Biodiversity Conservation Act 1999 by the Department of Sustainability, Environment, Water, Population and Communities (SEWPaC). Following this the Parliamentary Public Works Committee (PWC) must also approve the proposed capital works before any procurement or construction can begin. The project proposal is expected to be put before the PWC by the end of 2012 once the concept design work is complete.

As part of developing the project, DAFF is holding a series of briefing sessions in late October to provide stakeholders with details on outcomes of the design process to date. At this stage, we would propose to host a number of sessions, tentatively scheduled as follows:

Sydney 24 October 2012

cats and dogs, horses, bees, plants

- Brisbane 25 October 2012
 - all species

Melbourne 1 November 2012

cats and dogs, horses, live birds and hatching eggs, plants

The details of the venues and times for each session are still being finalised – we will provide further details in the next two weeks as likely attendee numbers for each session are known. The ADF has finally caught up with the US Army in this regard.

This is a real morale booster, whether you agree with our troops being there or not.

Free postage if the Care Parcel weights LESS THAN 2 kgs.

- 1 Buy a BX2 Mailing Box [310mm x 225mm x 102mm] from the Post Office, cost \$2.35 & ask for a Customs Docket CN22.
- 2 Pack some goodies eg pack of Schmackos, some wrapped 2x2 or 4x2 dog biscuits, 2 or 3 tins sardines in olive oil, a tennis ball, a tug toy or Frisbee, some lollies for the Handler.
- 3 Total cost \$very little & you'll feel good about it.
- 4 Fill out the Customs Form.
- 5 Put a note in the box for the Handler.
- 6 Don't seal the box, take the box & Customs Form to the PO & have them weigh the box & goodies.
- 7 Add or subtract an item to bring the total weight to 2kgs. The PO will seal the parcel for you.

'And then, pop! My Mom had this bag of water she kept in there in case he got thirsty, and it just blew up and spilled all over the bed, like psshhheew!' (This kid has her legs spread with her little hands miming water flowing away. It was too much!)

'Then the middle wife starts saying 'push, push,' and 'breathe, breathe.

They started counting, but never even got past ten. Then, all of a sudden, out comes my brother. He was covered in yucky stuff that they all said it was from Mom's play-center, so there must be a lot of toys inside there. When he got out, the middle wife spanked him for crawling up in there in the first place.'

Then Erica stood up, took a big theatrical bow and returned to her seat.

I'm sure I applauded the loudest. Ever since then, when it's Show-and-Tell day, I bring my camcorder, just in case another 'Middle Wife' comes along.
